Much of the equipment is jointly used and maintained by both the golf course and other city operations and city water main lines cross the course from the reservoir to town and city shops, the reservoir and maintenance sheds are on the golf course tax lot. Since the golf course bonds were paid off in 1980 no tax dollars have been been expended on the course and over the years the course has repaid the general fund for the bond payments. Under state budget and audit laws, the course is operated as an "Enterprise" Fund, which means it must operate like a private business with expenses such as staff time and water charged back to the golf course.
